Should any dispute arise with regard to this agreement, at the request of either party it may be decided by arbitration to be conducted in Rutland, VT, in accordance with the rules of the American Arbitration Assoc. The decision made and any award rendered by the arbitrator shall be final and may be entered and enforced as a final judgment in a court of competent jurisdiction within the State of Vermont. No matter where signed, this Agreement shall be governed by the laws of the State of Vermont and contains all agreements of the parties.

We understand that this agreement contains an agreement to arbitrate. After signing this document, we understand that we will not be able to bring a lawsuit concerning any dispute that may arise which is covered by the arbitration agreement, unless it involves a question of constitutional or civil rights. Instead, we agree to submit any such dispute to an impartial arbitrator.

Although we have worked successfully with many boys as they are maturing into young men, Night Eagle is not trained or licensed to work with troubled boys. Our program is designed for boys who enjoy being in the outdoors and are excited about learning wilderness skills. Your answers to the following questions will help us as we work with you son this summer.

1. What are your son's particular strengths? In which areas does he shine?

2. Are there areas in which your son has particular difficulty? If so, is he receiving help in those areas?

3. How does your son interact with other children individually or in a group? Night Eagle cannot accommodate boys with a history of social or behavioral disorders or a history of causing problems at home or in school.

4. When a boy comes to camp from a home that is undergoing change (new location, new school, separation, etc) his experience and adjustment is often affected. Are any of these changes a part of your son's life, and if so, how is he adapting?

5. What do you particularly wish your son to gain from his experience at Night Eagle Wilderness Adventures?
